UPDATE FROM THE MINISTRY OF HOUSING, COMMUNITIES AND LOCAL GOVERNMENT

10th July 2025 – English Devolution and Community Empowerment Bill published.

As part of the introduction of the Bill, MHCLG has published the following documents which APCC members may find useful to reference:

The APCC circulated a briefing summarising key aspects of the Bill – attached to this circular.

17th July 2025 – Ministerial statement on Devolution Priority Programme (DPP) areas <u>Statement</u> from Jim McMahon confirming all six DPP areas met the relevant statutory tests and that legislation will be brought before Parliament to establish each of the six institutions early in 2026.

The MHCLG has also published a summary of responses and the government's response to the individual consultations in each of the six DPP areas.

15th July 2025 - Launch of APCC guidance on transfer of police and crime functions to a Mayoral Authority

This APCC guidance produced in partnership with the Local Government Association and Leapwise is designed to support P(F)CCs and their offices plan for the changes that need to be considered in readiness for the transfer of policing and crime functions to a Mayoral Authority.

The report is currently being reviewed against the recently published English Devolution & Community Empowerment Bill.

15th July 2025 – Ministerial briefing for P(F)CCs and Deputy Mayors

Minister for English Devolution and Local Government, Jim McMahon provided a briefing to P(F)CCs and Deputy Mayors on the English Devolution & Community Empowerment Bill. This was followed by a Q&A.
