

#### Fraud & Cyber - Gielgud Room

The police are "on the brink... of a cybercrime crisis" according to Wired Magazine. But what is the truth behind the headline? Cybercrime accounted for roughly 30% of all UK crime between July 2016 – 2017 (ONS). While cybercrime can take many forms, 50% of fraud incidents in 2017 were cyber-related (CSEW), defrauding victims out of billions of pounds a year, and proceeds often funding organised crime groups. Cyber-crime is a unique issue, not constrained by borders or limited by location. But efforts to curb online fraud and cybercrime have led to multiple success stories. Our panellists represent organisations across UK law enforcement and government, focussing on fraud and cybercrime at the local, national, and international level. Join us for a discussion on how the landscape around cybercrime and fraud has shifted and what is being done to combat the challenge we face.

Next year the Government will carry out a departmental spending review and it is critical that policing makes a robust, evidence-based case for resourcing the service. The Home Office is working with PCCs and law enforcement leads to develop and deliver the submission.

Police figures reveal an increase of 11% in gun crime compared with 2016, and a 22% increase in offences involving knives or other sharp instruments. ## **APCC and NPCC Partnership Summit Biographies**

#### Mark Burns-Williamson OBE

Chair, Association of Police and Crime Commissioners and Police and Crime Commissioner for West Yorkshire

In November 2012 Mark was elected as the first Police and Crime Commissioner (PCC) for West Yorkshire and re-elected in May 2016. He was elected as Chair of the Association of Police and Crime Commissioners in July 2018. He has a long history in police governance, having been appointed to West Yorkshire Police Authority in June 1999 and served as both Chair of the Authority (from June 2003), and Deputy Chair and Chair of the Association of Police Authorities (APA) serving as outgoing Chair and overseeing the national transition to the Association of Police and Crime Commissioners (APCC) in 2012.



Mark has spent over 30 years working for both public and private sector organisations in West Yorkshire, including West Yorkshire County Council, Wakefield Council, Citizens Advice Bureaux, CableTel Ltd, The Rugby Football League (RFL) and Halifax Bank Plc. In the 2012 Honours List, he was awarded an OBE for services to the community and policing.

Mark has instigated a number of initiatives, including establishing the Safer Communities Fund (SCF) where assets seized from Criminals (POCA) have been used to support more than 500 local community projects. He also launched the National Anti-Trafficking and Modern Slavery Network in 2016 and is the national APCC lead for forensics and police aviation.

#### Chief Constable Sara Thornton CBE QPM

Chair, National Police Chiefs' Council

Sara Thornton is the first Chair of the National Police Chiefs' Council. Sara joined the Metropolitan Police Service in 1986 and over the next fifteen years her career alternated between operational postings in West London and strategic roles within New Scotland Yard. She served with Thames Valley Police as Assistant Chief Constable, Deputy Chief Constable and Acting Chief Constable before holding the role of Chief Constable for eight years until March 2015. She has also been Chair of ACPO Intelligence Portfolio, Vice-Chair of ACPO Terrorism and Allied Matters, Director of the Police National Assessment Centre and ACPO Vice-President.



Sara is a member of the Royal College of Defence Studies, the Advisory Board for the Oxford University Centre for Criminology and the International Advisory Board for the Cambridge Executive Police Programme. She is a graduate of Durham University, also holding a Master of Studies (MSt) degree in Applied Criminology and Police Management from Cambridge University alongside honorary doctorates from Oxford Brookes University and Buckinghamshire New University.

Sara was awarded the Queen's Police Medal in 2006 and made a Commander in the Order of the British Empire in 2011. She has also been recognised with a Career Achievement Award from the Police Training Authority Trustees and the Sir Robert Peel Medal for Outstanding Leadership in Evidence-Based Policing.

#### The Rt Hon Sajid Javid MP

Home Secretary

Born in Rochdale and raised in Bristol, Sajid attended a local state school, where he went on to read Economics and Politics at Exeter University. Sajid became involved with politics whilst at school, an interest that continued at university.



Before being elected MP, he worked in business and finance. Aged 25, he became a Vice President at Chase Manhattan Bank. He later moved to Deutsche Bank in London to help build its business in emerging market countries. Sajid left Deutsche Bank as a senior Managing Director in the summer of 2009 to give something back through politics.

Sajid has served as the Member of Parliament for Bromsgrove since 2010 and has held several positions in government.

Police and Crime Commissioner for Hertfordshire and Chair, Police Reform and Transformation Board

David Lloyd was elected as Police and Crime Commissioner for Hertfordshire in 2012, and re-elected in 2016. This year he chairs the Police Reform Transformation Board following a successful term as Chair of the Association of Police and Crime Commissioners in 2017-18. He leads on the criminal justice portfolio for the APCC, and chairs Hertfordshire's Local Criminal Justice Board.

His Police and Crime Plan focuses on reform of the criminal justice system, calling for better system leadership and greater accountability. He also advocates a joined-up approach to community safety and has proposed an innovative way of working with partners that does not involve taking on governance.

Before his election as PCC, David was deputy leader of Hertfordshire County Council, and a borough councillor in Dacorum. In that time, he was chair of the Hertfordshire Police Authority and was the executive member for the Fire and Rescue Service at the county council.

His first career was in banking working for Lloyds in a variety of roles and then became a financial advisor.

He has a degree in French Language and Literature from the Universities of Birmingham and Lyon and is a Fellow of the Royal Society of Arts.

#### Sir Michael Barber

Founder and Chairman of Delivery Associates and former Head of the Prime Minister's Delivery Unit

Sir Michael Barber is a world-leading authority on the effectiveness of government. He is the Founder and Chairman of Delivery Associates. In March 2015 his latest book How to Run a Government so that Citizens Benefit and Taxpayers Don't go Crazy was published by Penguin to wide acclaim.



Since 2009, on behalf of the British Government, he has visited Pakistan more than 50 times to drive delivery of improved outcomes in the education and health systems of Punjab. With his leadership, Delivery Associates has worked with government leaders in the developing and developed world to enable them to deliver their domestic policy priorities. These include the governments of Ethiopia, Canada, New South Wales in Australia and Western Cape in South Africa. In 2017 he was commissioned by Her Majesty's Treasury to review efficiency and public value. His report "Delivering better outcomes for citizens: practical steps for unlocking public value" was published with the budget in 2017.

He is a distinguished visiting scholar at Harvard School of Public Health and holds honorary doctorates from The University of Exeter, The University of Wales and The University of Warwick. In 2005, he was knighted for his services to improving government.

#### Lynne Owens CBE QPM MA

Director General, National Crime Agency

Lynne Owens took up post as the Director General of the National Crime Agency (NCA) – a PUS graded position - on 4 January 2016 following a 27 year career as a police officer, serving in 3 forces. The NCA leads the UK's fight to cut serious and organised crime by continually developing the best intelligence picture, investigating those offenders operating at the high end of high risk and developing and hosting new capabilities to respond to rapidly changing threats. She is a member of the Government's National Security Council and chairs the National Strategic Tasking and Coordination Group, ensuring an effective national response to priority threats, including Child Sexual Exploitation and Abuse, Modern Slavery and Human Trafficking, Money Laundering, Cyber Crime and the illicit supply of firearms to the UK.



An experienced police officer, Lynne joined the Metropolitan Police Service in 1989 and served initially as a Constable in Catford. She later moved to Kent Police as a Sergeant where she rose to the rank of Detective Chief Inspector and Senior Investigating Officer within the Force's Major Crime Department. Lynne transferred to Surrey Police in 2002 where she served as a Divisional Commander. She later completed the Strategic Command Course at Bramshill Police College and subsequently became Assistant Chief Constable, responsible for Territorial Operations. Awarded the Queen's Police Medal in 2008, Lynne became temporary Deputy Chief Constable before moving back to the MPS as a Deputy Assistant Commissioner in 2009. She was promoted to Assistant Commissioner the following year, serving as head of Central Operations and Specialist Crime Directorates.

#### Chief Constable Olivia Pinkney QPM

Hampshire Constabulary

Olivia is the national lead for Children and Young People, chair of the Uniformed Policing Professional Community of the College of Policing, and the national chaplaincy lead for the police service. Olivia began her policing career with Avon and Somerset Constabulary. She later served as assistant chief constable for Surrey and Sussex forces before being appointed deputy chief constable at Sussex. Julia Mulligan

Police and Crime Commissioner for North Yorkshire and APCC Lead for Integrity and Transparency

Now serving her second term, Julia was re-elected as North Yorkshire's Police and Crime Commissioner in May 2016. During her tenure, Julia has focused on improving victim services, particularly for vulnerable people. She takes an evidence-based approach, using research and insight to shape services, which have included wide-ranging improvements to domestic and sexual abuse support, as well as establishing an in-house team to support victims more widely across North Yorkshire. Julia is also a vigorous campaigner, championing a range of causes including improving the police complaints system and the opening of four health-based places of safety in North Yorkshire, as an alternative to police custody for people detained under the mental health act.



Julia holds a number of local and national positions, including chairing North Yorkshire's Local Criminal Justice Board, co-chairing the Crisis Care Concordat and the National Rural Crime Network, which she was instrumental in establishing in 2015. Julia was also the first chair of the National Police Reform and Transformation Board and is a Director of the Association of Police and Crime Commissioners. Julia also maintains her interest in police complaints and conduct, holding the APCC national portfolio for police integrity. Prior to her election as Police and Crime Commissioner, Julia enjoyed a successful business career, working as a consultant in London and internationally, before setting up her own company in Yorkshire, which specialised in working with the NHS and other public sector partners. She previously served as a local District Councillor in Craven where she lives and stood for Parliament in the 2010 General Election.

**Chief Constable Craig Guildford** 

NPCC Lead for Complaints and Misconduct and Nottinghamshire Police

Craig joined Nottinghamshire Police as Chief Constable in February 2017, moving from Deputy Chief Constable in Gwent, a role he commenced in April 2014. Prior to this he served as Assistant Chief Constable (Specialist Operations) in West Yorkshire Police. His policing career began in 1994 when he joined Cheshire Police, after completing two years as a Special Constable.

NPCC Lead for Mental Health & Policing and Dyfed-Powys Police



Police and Crime Commissioner for Lancashire and APCC Lead for Fraud and Cyber Crime

Clive Grunshaw was elected as Lancashire's first Police and Crime Commissioner in 2012 and was re-elected in 2016. Clive is also the APCC Lead for Fraud and Cyber Crime nationally. Prior to his current role, Clive was a borough and county councillor, worked as Cabinet Member for Children and Young People on Lancashire County Council and a member of the Police Authority.

Clive believes that the role of PCC is all about delivering for the people of Lancashire, acting as the people's voice in policing and ensuring that policing is delivered to the standard that the public would expect at a time when the service is over-stretched. As APCC lead for Fraud and Cyber Crime, he also understands that the online threat is one of the biggest challenges facing policing, with online crime now accounting for over half of all crime committed today.

Deputy National Coordinator, Fraud and Economic Crime, City of London Police

Alex joined the City of London Police in November last year on secondment from the Metropolitan Police and performs a national role focused on improving the policing response to fraud and economic crime.

He has had a varied and fulfilling career performing investigative and intelligence gathering roles targeting a wide variety of crime types, particularly organised crime. He has considerable experience working in multi-agency environments and has previously performed secondments with Customs and Excise, SOCA and the NCA. From 2012-2015 Alex led a joint NCA/MPS

task force and has previously led the MPS Cyber Crime Unit and Fraud teams. In the year prior to joining the City of London Police, Alex was the lead for a major internal transformation project focused on the Met's Specialist Operations Business Group. In addition to his day to day responsibilities Alex is an active hostage and crisis negotiator and has considerable experience in the investigation and management of kidnap, blackmail and extortion.

#### **Pauline Smith MBE**

Director of Action Fraud, The National Fraud & Cyber Reporting Centre UK

#### Sir Philip Rutnam KCB

Permanent Secretary, Home Office

Philip Rutnam joined the Home Office as Permanent Secretary in April 2017. Prior to that, Philip was the Permanent Secretary at the Department for Transport for five years. In April 2015, Philip became the Civil Service Disability Champion. Philip had previously been Director General, Business and Skills, at the Department for Business, Innovation and Skills where he was responsible for policy towards and industry and enterprise, including economic development across the regions and support for small business, and for further education policy including apprenticeships and the Skills Funding Agency.



Prior to BIS, Philip was at Ofcom where he helped to establish the organisation and then to lead its work on competition, economic regulation and use of the radio spectrum. He was a partner at Ofcom from 2003 and a member of the Ofcom Board from 2007 to 2009.

Police and Crime Commissioner for Leicestershire and APCC Brexit Working Group

Following a high profile career in both criminal justice and public service, he brings valuable experience to his new role as PCC for Leicester, Leicestershire and Rutland.

He was a criminal law barrister, prosecuting and defending at the Leicester Bar for 25 years. He was an elected Councillor on both Leicester City and Harborough District Councils.



A Leicester City football season ticket holder for over 40 years, he also enjoys cricket, music and hard boiled American crime fiction. Married, with three children, he lives near Lutterworth.

**Martyn Underhill** 

Police and Crime Commissioner for Dorset and APCC Brexit Working Group

Prior to his first election as Police and Crime Commissioner (PCC) for Dorset in 2012, Martyn was a police officer for 30 years. He joined the Metropolitan Police in 1979 before transferring to Sussex Police in 1984 where he rose through the ranks to Detective Chief Inspector. He was best known for being second in charge of the Sarah Payne murder.

Following his retirement from the police service, Martyn campaigned for child safeguarding issues including Sarah's Law (the child sex offender disclosure scheme) and sat on his Local Child Safeguarding Board as an Independent member. Martyn Underhill has now been Dorset PCC for six years, having been re-elected in 2016. Martyn led on mental health nationally for PCCs from 2012 to 2017, stepping back to concentrate on the proposed merge of Dorset Police with Devon and Cornwall Police. Martyn still represents PCCs at a national level in relation to Brexit, police custody and use of force issues. Since 2014, he has been the Chair of the Independent Custody Visiting Association. He volunteers or is a trustee/chair for a number of charitable organisations and trusts, including The Police Scholarship Trust, the UK Police Memorial Trust and five local Dorset charities.

#### Chief Constable Charlie Hall OPM

NPCC Lead for Operations and Hertfordshire Constabulary

Charlie Hall QPM is Chief Constable for Hertfordshire Constabulary and was appointed to the role in October 2016. Nationally, Charlie not only leads for the National Police Chiefs' Council on ANPR, but also the Operations Coordination Committee and on the policing of industrial disputes. He is also the National Police Lead for Brexit as well as the senior responsible officer for the JESIP programme which improves interoperability across the blue light services.

Charlie places an important emphasis on local policing and the potential impact upon policing of Brexit continues to be reviewed and assessed. Leading this work nationally Charlie plans to mitigate the impact upon local and national policing providing reassurances to government and communities. Charlie previously served with Norfolk Constabulary and is married with a young son and two daughters at University.

#### **Deputy Assistant Commissioner Richard Martin**

NPCC Lead for International Criminality and Brexit and Metropolitan Police Service

Richard Martin is a Deputy Assistant Commissioner within the Metropolitan Police Service (MPS).

After serving five years in the British Army, Richard began his policing career within the West Midlands Police, where he served for eight years in a variety of uniform and detective roles up to the rank of Detective Chief Inspector. In 2002, Richard was appointed as Head of Intelligence for the National Criminal Intelligence Service (later becoming part of the Serious Organised Crime Agency, now the National Crime Agency). In this role, Richard was responsible for conducting covert operations aimed at tackling serious and organised crime.

It was also during this period that Richard led the DVI response into the MH17 plane crash within the Ukraine, assisting the international effort to recover, identify and repatriate the victims of the disaster.

He is the NPCC lead for the newly established International Criminality Portfolio leading critical areas for UK law enforcement which include European legislative tools, the response to tackling foreign national offenders and Brexit.

#### **Paul Lincoln OBE**

Director General, Border Force, Home Office

Paul's career has covered a broad range of roles in the Ministry of Defence (MOD), the Home Office and the Cabinet Office. Immediately prior to this appointment, he was Director General of the Crime, Policing and Fire Group (CPFG) in the Home Office. Shadow Home Secretary

In 1987 Diane Abbott made history by becoming the first black woman ever elected to the British Parliament. Upon leaving Cambridge, where she obtained a Masters Degree in history, Diane joined the Home Office as a civil servant. She went on to work for the lobby group The National Council for Civil Liberties before moving into journalism.

From the outset of her career, Diane has championed global justice, human rights, peace and security issues at home and abroad. She has been a vocal campaigner around race-relations, transparency and justice around policing, surveillance, Stop and Search, and detainment without trial, as well as a key advocate of proportional representation.

She was elected on to the National Executive of the Labour Party and, for most of the 1990s, served on the Treasury Select Committee. In 2015, Diane was re-elected to her Hackney North and Stoke Newington constituency with a landslide majority and, in September 2015, was appointed Shadow Secretary for International Development. Diane then went on to become Shadow Secretary for Health and is now the first black female Shadow Home Secretary.

#### Roger Hirst

Police. Fire and Crime Commissioner for Essex and APCC Lead for Finance

Roger Hirst was elected as the Police and Crime Commissioner for Essex in May 2016. He believes that safe and secure communities are the bedrock on which we build wellbeing and prosperity for all. He committed in his Police and Crime Plan to increase the local, visible and accessible nature of policing in Essex, crack down on anti-social behaviour and protect children and vulnerable people, as well as continuing to address domestic abuse, deal with gangs and serious violence, and improve road safety.



Mr Hirst is a strong advocate for prevention and partnership: he has championed the role of the Special Constabulary, and has gathered the resources for an increase in the number of officers within Essex and to provide officers with the technology they need to be more efficient and visible within their communities.

In 2017 Mr Hirst became the joint lead for police funding on behalf of the Association of Police and Crime Commissioners nationally and was elected to the board of the Association of Police and Crime Commissioners in 2018.

NPCC Lead for Finance and West Midlands Police

NPCC Lead for Crime Operations and Durham Constabulary

Michael is an adopted North Easterner who served in Lancashire for 28 years before joining Durham Constabulary in 2008 as ACC. He has been Chief Constable since 2012. Michael has led new ways of tackling organised criminals through challenging traditional ways of policing and encouraging paradigm shifts. Durham is now recognised as a leading force in tackling serious and organised crime and managing offenders. He is the National Policing Lead for Crime and intends to use this position to ensure British Policing is in the vanguard of tackling crime on the internet. Michael at his worst has been described as a maverick and at his best as a maverick. He has enjoyed a few scrapes and still pinches himself every morning that someone asked him to be a Chief Constable.

#### Rebecca Lawrence

Chief Executive, London Mayor's Office for Policing and Crime

Rebecca Lawrence is Chief Executive Officer of the Mayor's Office for Policing and Crime (MOPAC), through which the Mayor of London and his Deputy Mayor for Policing and Crime set the priorities, agree the budget and scrutinise the performance of the Metropolitan Police Service. Rebecca has extensive experience at the most senior levels of national policing and security, serving as Director of the Office of Security and Counter Terrorism at the Home Office and as Director, Terrorism and Allied Matters for the Association of Chief Police Officers before moving to MOPAC as Director of Strategy in 2013. She has advised Ministers, and represented the Government and the Mayor nationally and internationally on economic, crime and security

issues. Rebecca began her career in the Civil Service, spending 16 years at HM Treasury working on portfolios ranging from environment and energy to European trade and investment. A lifelong Londoner, Rebecca lives in West London with her husband and two sons.



NPCC Lead for Serious Violent Crime and Bedfordshire Police

ACC Jacqueline Sebire joined Bedfordshire Police in February 2016. She joined the force as a detective chief superintendent and was instrumental in the creation of the Emerald team which gave a dedicated approach to domestic abuse and sexual offences. The majority of her service before joining Bedfordshire was as a detective in homicide and serious crime investigations in the Metropolitan Police. She was the senior investigating officer for a number of high profile cases including the 'Spy in the bag' case and the conviction of Britain's youngest hit man. She has also served in the London Boroughs of Newham, Hackney and, prior to transferring to Bedfordshire, was the Temporary Borough Commander for Waltham Forest. Jacqueline has a PhD

in Forensic Psychology and in January 2016 was appointed a Visiting Scholar at the University of Cambridge. She has published a number of articles in relation to domestic abuse and risk management. Head of Policy and Public Affairs, Children's Commissioner for England

Emily Frith is Head of Policy and Advocacy for the Children's Commissioner, leading their work to influence public policy on all matters involving children. She came from the Education Policy Institute where she was Director of Mental Health from 2015-2017. In 2015, she coordinated a cross party Equality for Mental Health campaign which influenced a Budget announcement of £600m for mental health. Prior to this she was a Special Adviser to the Deputy Prime Minister from 2013-2015 covering health and welfare, during which time she helped to deliver improvements to mental health services, including the first ever national waiting time standards. She is the author of seven policy reports into children and young people's mental health, including a literature review of the impact of social media on young people's wellbeing.

Head of Serious Violence Unit, Home Office

Alison Hernandez is the Police and Crime Commissioner for Devon, Cornwall and the Isles of Scilly and leads on road safety for the Association of Police and Crime Commissioners. Alison grew up in Torquay before securing an honours degree in Sociology from Kingston University and studied marketing at Plymouth Business School. In her early career, Alison worked in public service and served as an elected councillor in Torbay. She went on to run her own management consultancy working internationally to help companies in the housing and transport sectors with business improvement.



Alison was elected Police and Crime Commissioner in 2016 and established a plan for safe, resilient and connected communities. Road safety is an issue of key importance to Devon and Cornwall which faces challenges presented by a largely rural road network which is not geared up for modern traffic conditions, amplified by the millions of visitors welcomed to the area each year. Police and Crime Commissioners are directly elected by the public and are responsible for the totality of policing and tackling crime. This includes setting the police budget, establishing the police and crime objectives for the area and holding the Chief Constable to account for the delivery of policing.

#### **Glyn Wallis-Jones**

National Police liaison officer for the Department for Transport

Glyn Wallis-Jones served for 30 years with the Metropolitan Police retiring as a Detective Chief Superintendent in September 2014. During his service he was involved in Borough and public order policing. He was a senior investigating officer running a murder investigation team and a Borough crime manager. His final operational posting was as the operational head of roads policing for London where he devised and led Operation Safeway designed to reduce cyclist injuries and fatalities on London roads. In January 2015 he became the national police liaison officer for the Department for Transport. His role is to bring a practical understanding of operational policing to those responsible for formulating policy and new legislation. This has included work around the introduction of the drug driving legislation and the development of mobile evidential breath testing equipment.

He is involved with projects with other government departments including the Home Office on such issues as communication and enforcement technology in police vehicles, European cross border enforcement issues and the use of technology in collision reporting. He is currently leading on the roll out of the replacement CRASH collision reporting and investigation system which DfT is providing free to police forces.

He was also responsible for designing and implementing the National Counter Terrorism Co-ordination Centre at New Scotland Yard and was Borough Commander for Lambeth before his promotion to Commander in Territorial Policing where he has led on Criminal Justice, Custody and Crime Policy for the MPS.

Dame Vera Baird QC

Police and Crime Commissioner for Northumbria and APCC Lead for Supporting Victims and Reducing Harm

Dame Vera Baird is currently the Police and Crime Commissioner for Northumbria having been elected to the post in 2012, and then re-elected in 2016 with a majority of more than 120,000. She also serves in several voluntary roles as an Honorary Doctor of Civil Law at Northumbria University, Visiting Professor of Legal Practice at Newcastle University, Visiting Law Professor at London South Bank University, Visiting Law Lecturer at Teesside University and as an Honorary Fellow of St Hilda's College, Oxford and Durham University Law School. Dame Vera was previously Labour Member of Parliament (MP) for Redcar from 2001



- 2010, UK Government Minister from 2006 - 2010 and the UK Government's Solicitor General for England and Wales from 2007 to 2010 - the House of Common's most senior law officer. As Solicitor General she was particularly involved in criminal justice policy and legislation, especially on gender and equality policies. In 2017 she was appointed Dame Commander of the Order of the British Empire (DBE) for services to women and equality. She is also the only honorary woman member of the Durham Miners' Association as well as a Patron of the charity RESPECT.

Dame Vera is recognised as being a strong voice for the North East, speaking up for Northumbria Police force, partners and communities at a local and national level. She also helped the Labour Party develop policy in ensuring women's needs are fully met through the Women's Safety Commission.

**Baroness Helen Margaret Newlove** 

Victims' Commissioner for England and Wales

Baroness Helen Newlove was appointed Victims' Commissioner (VC) for England and Wales in December 2012. The Commissioner's role is to champion the interests of victims and witnesses; encourage good practice in their treatment and monitor compliance with the Victims Code. The Commissioner campaigns tirelessly to help crime victims and she travels the country, meeting victims and listening to their experiences. She regularly meets with all heads of the Criminal Justice agencies, Chief Constables, Police and Crime Commissioners, victim organisations and voluntary groups. She has undertaken many key reviews, including the handling of victim complaints, restorative justice and the victim personal statement. Her priorities as



VC for 2018 includes; scrutinising the needs of vulnerable victims, registered intermediaries, criminal injuries compensation and victims of mentally disordered offenders. Baroness Newlove is a keen campaigner for a "Victims' Law" to guarantee victims a set of legally enforceable rights. Victims and crime are both causes close to her heart. In August 2007, Baroness Newlove became a crime victim herself, when her husband Garry was fatally attacked by a gang on the family's doorstep. The murder shocked the nation and hit the headlines for months. When she spoke out against anti-social crime, her speech struck a chord and she became a committed campaigner against anti-social abuse. Baroness Newlove was given a peerage in 2010 and appointed Government Champion for Active, Safer Communities. Today she sits in the House of Lords as an active Conservative peer and a Deputy Speaker. Baroness Newlove is in increasing demand on TV, radio and in the press. Her high-profile media appearances include; BBC Breakfast, Sky News, Channel 4, Radio 4's Today and LBC and she regularly reviews the newspapers on Sky and BBC Radio.

**Sue Hemming OBE** 

Director of Legal Services, Crown Prosecution Service

Sue Hemming joined the CPS in 1988 and worked in Cambridgeshire before joining the CPS Casework Directorate in 2000 where she led one of the branches that specialised in Special Crime work and had the CPS lead for extradition. In September 2002 Sue took over responsibility for prosecuting terrorism, international crimes and official secrets. She was made the Head of the new Counter Terrorism Division when it was created in 2005 and was awarded an OBE in the New Year's Honours list the same year. Sue took over the expanded Special Crime and Counter Terrorism Division in April 2011, widening her responsibility to include the other complex and high profile casework such as deaths in custody, police corruption, corporate manslaughter



and the appeals and review unit. Sue has worked closely with the police, intelligence services and others to develop policy and guidance and to build strong cases enabling the CPS to bring terrorists to justice across a range of developing threats. Since 2012, she has been closely involved in the Hillsborough investigations which have been the largest in English criminal history. Sue took up her role as Director of Legal Services on 1 August 2018

#### **Richard Atkinson**

Co -Chair of the Law Society's Criminal Law Committee.

He is the Managing Partner of the Kent branch of Tuckers LLP, a specialist criminal law practice in Kent and has specialised in criminal law for over 25 years. His principal focus is now on litigation conducting his firm's more serious cases which have included many high profile cases including the largest cash robbery (£53 Million) in UK history, a woman charged with five counts of murder and he has also advised a number of senior bankers who were being investigated in relation to the foreign exchange collusion allegations. He is a duty solicitor, a member of the National Disclosure Forum, the PACE Review Board, the Kent Criminal Justice Board and the National Implementation Team for Transforming Summary Justice and Better case Management. Richard was a member of the board of Lord Justice Leveson's Review of Efficiency in Criminal Proceedings. He is

He has given evidence to Parliamentary Committees most recently on the Counter Terrorism and Border Control Bill.
